Community First Responders in Fairford, Lechlade and Kempsford

When on duty, volunteer Community First Responders (CFR) are called by the Ambulance Control to incidents within their rural area. Originally, the focus was upon immediate life critical events, such as Sudden Cardiac Arrest. Now CFRs are trained to deal with just about anything that an Ambulance may be called to – except Road Traffic Collisions and pub

fight!

With the Covid-19 Lockdown in March 2020 we were initially stopped by the Ambulance Service from responding whilst they worked out what our new working protocols would be and made sure that we had the right protective equipment. It took two or three weeks before we were given clearance to do so. We did of course deploy to incidents that included heart attacks, but also those who, but for the Pandemic, might have gone out to the Doctor, Pharmacist or taken themselves to a Minor Injuries Unit. The problems we saw evolved and, with the support of a clinician at Ambulance Control we were often able to help prioritise incidents or ensure a patient was dealt with without the need for an Ambulance attending.

Members of the Group also helped in other ways over the months following that first lockdown. One trained to drive an Ambulance operationally, another helped with the issue to crews and fitting of specialist protective equipment, Ambulances were redeployed, **Community Defibrillators regularly checked as “rescue ready”** and crew welfare stations manned at the Emergency Departments of our Hospitals.

Improvement in our capability has continued. Over the last year, we have all been trained and have achieved a new National Ambulance Responder qualification. **Things are returning to a “new normal”** with

our “normal” monthly training meeting moving back from Zoom to a “more normal” training session. Inevitably, some find that they can no longer respond or move out of the area and the Pandemic did not stop that. However, we now have four new CFRs (two each in Fairford and Lechlade) who have recently qualified (See photo) and, after completing a couple of training shifts, will soon become active in our

communities. That will mean that we should soon be back to having a team of 10 responders across the Fairford and Lechlade area.

I am sure though that things will continue to move on. The Ambulance Service have plans to further improve our capability and equipment, and we will still need new volunteers to train up to add to the Group or replace those who may need to retire as things change for them.

Vicar's Newsletter Kempsford & Whelford, end May 2022

The sun is shining, after a few days of much needed heavy rain. Plants – and weeds – will **now launch into a growing spurt!** I thank God that the natural world continues its' cycle, in spite of the difficulties all around us. The church year leads us through the same cycle, with the birth of Jesus as Christmas, his death at Easter followed by the recovery of hope at the resurrection. Now we are approaching Pentecost, the time when we celebrate the start of the church, which gathers us to worship and share the good news that God loves us and has built us together into his family.

Family is a good thing when it works, a place where we are accepted and known, where we care for each other through the ups and downs of life. A place where we eat and laugh together, sharing the burden of keeping afloat in stormy seas. Some of us live **alone and don't have family members locally. We can wonder how we will manage, with** costs rising and stressful news bombarding us from the news channels. On Friday 24th June, **at St. Mary's church we are hosting a concert** in aid of those who are suffering in Ukraine. Doors open 6.30pm for 7pm start. Step 1: What's the problem?

I suddenly have no money

- Lost job/reduced hours
- Lost money/unexpected expense
- Disaster (e.g. flood or fire)
- Relationship breakdown
- Money stopped (e.g. failed a medical)
- Sanctioned - see option 5

See options **1 2 5 6**

I am waiting on a benefit payment/decision

- Made a new claim for benefit
- Benefit payment is delayed
- Waiting for a benefit decision

My money doesn't stretch far enough

- Deciding between food/fuel/mobile credit
- Low income or zero hours contract
- Statutory Sick Pay too low to cover costs
- Facing redundancy
- Not sure if eligible for support
- Change of circumstance (e.g. new baby/bereavement/illness/left partner)

I have debt

- Rent or Council Tax arrears
- Gas or electricity
- Credit or store cards
- Personal loans and overdrafts

Step 2: What are some options?

1 Council Support Schemes

People on low incomes may be eligible for **Housing Benefit, Discretionary Housing Payments** and **Council Tax Support** from the council. This will depend on your current circumstances. Find out more at:

2 Maximise Your Income

Anyone who is struggling financially can get a benefit check and speak to an advisor for free and confidential advice.

A **benefit check** can ensure that you are receiving all the money you're entitled to, especially if your circumstances have changed recently. Speaking to an advisor could also help you **find cheaper deals** on things like gas and electricity and **make sure you're not missing out** on things like school clothing grants or free school meals.

3 Debt Advice

Debt can happen to anyone. Free advice and support can help you find ways to manage your debts and reduce how much you pay each month.

4 Benefit Advance

If you have made a new claim for benefit and are in financial hardship while you wait for your first payment, you may be able to get an advance to afford things like rent or food. It's important to get advice before taking out an advance. Benefit advances must be paid back, and the money will be taken from your future benefit payments (a loan).

5 Hardship Payment

If you have been sanctioned, you may be able to request a hardship payment from the Jobcentre. Hardship payments are not always paid immediately, and they're not available to everyone. Hardship payments of Universal Credit need to be paid back (a loan), but hardship payments of Job Seekers Allowance or Employment Support Allowance do not (not a loan).

6 Challenge a Decision

You can challenge a benefit decision if your benefit has been stopped / sanctioned / reduced / refused or you have been overpaid. Most benefit decisions need to be challenged within one month.
