TEMPORARY CLOSURE OF C/172 CHAPEL ROAD  
(KEMPSFORD PARISH) COTSWOLD DISTRICT

Gloucestershire County Council intend to make an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close part of C/172 Chapel Road from its junction with 400994 Top Road to outside the property known as Honeysuckle Cottage for a distance of approximately 100 metres.

The reason for the closure is for drainage works.

The road is expected to be closed from the 13<sup>th</sup> September 2021 until the 17<sup>th</sup> September 2021 only or until the works have been completed. ## Lake 104 Update

The temporary footpath closures implemented around Lake 103, 103A and 104 in March has sparked lots of comments and concerns.

There will be many people who have moved to the area who possibly are unaware of the planning permission granted back in 2010.

Kempsford and Fairford Council recognise the importance of the area for walkers and in particular the link between the Whelford Road and Fairford. We have had many discussions with the developers since the closures were put in place and are very pleased to say that they have agreed to allow more sections of path to reopen and also a temporary diversion route linking to the Whelford Road.

Alterations to the fencing and signage are currently being undertaken prior to it becoming an active construction site. It will also be monitored daily for health and safety purposes.

On the North side of the Lake - the erected fencing will remain in place as it will be required for some drainage work in the future. These works will be short and intermittent so in the meantime an opening will be created to allow access along the north edge of the lake. Any short subsequent closures will be advertised prior to works being undertaken.

Please note that the land is privately owned and although there is a public right of way/footpath around the lake, much of the land which we have been used to walking over the years is not a public right of way.

We STRONGLY request that the new fencing and signage is respected to prevent more extensive closures being put back. Construction is expected to take some time and it is hoped that by working together and being respectful of essential closures these can be kept to a minimum.



## **Don't lose your voice** – residents in the Cotswolds urged to check their voter registration details

Local residents are being reminded not to lose their voice on decisions that affect them by making sure their electoral registration details are up to date when contacted by the Council.

The annual canvass, which is run every year, will soon be taking place to ensure that Cotswold District Council can keep the electoral register up to date and identify any residents who are not registered to vote so that they can be encouraged to do so.

Residents will be sent a letter or email over the next few months with clear instructions asking them to confirm their details or update them.



Robert Weaver, Chief Executive and Electoral Registration Officer at Cotswold District Council, said: **“It’s important that residents lookout for messages from us so we can make sure we have the right details on the electoral register for every address in the Cotswolds ahead of future elections.**

**“Simply follow the instructions sent to you and if you receive an email, please respond to save us having to send any follow-up paper correspondence.**

**“If you’re not currently registered, your name will not appear in the messages we send. If you want to register, the easiest way is online at [gov.uk/register-to-vote](http://gov.uk/register-to-vote), or we’ll send you information explaining how to do this in the post.”**

The emails should not be confused for a scam - all emails will be sent from **[elections@cotswold.gov.uk](mailto:elections@cotswold.gov.uk) with a subject line of ‘Cotswold District Council – Electoral Registration Canvas’.**

People who have moved recently are particularly encouraged to look out for the voter registration messages and check the details. Research by the Electoral Commission, published in 2019, indicates that recent home movers are far less likely to be registered than those who have lived at the same address for a long time (only 36% of people who have lived at an address for less than one year).

# Flood Defence

In recent weeks we will have all seen reports of flooding in Europe and whilst we would all hope never to see such volumes of water here we can all do our little bit to try and prevent the worst happening. In the June Newsletter we made **you aware of 'Floodsax' as a way of stopping water entering the home** and they are reasonably inexpensive and can be obtained locally at Travis Perkins (part number 868499).

During heavy rain approximately 600 gallons of water an hour can run from an average roof

An increasing proportion of flood insurance claims are now from surface water flooding, so we should all be aware and contribute to keep our villages as low risk as possible. A leaking gutter will severely increase the surface and groundwater around your home so ensure all seals are maintained and water is guided efficiently into your drain. Regularly inspect and keep your drains free from debris and blockages as excess water will either seep into the ground around your home or run away and contribute to the surface water around the villages. These simple things combined make a tremendous difference to our wellbeing.

On a wider note our local farmers help us so much by cutting drainage channels from the roads making sure surface water finds it way off the tarmac. They use their machinery to keep the ditches around the area clear and free from blockages and this vital work ensures water finds it way safely away from our villages. A big thank you to them.

We will continue to work with our local CDC councillor, Dom Morris , who is trying and get all the road drains cleared before the winter approaches. One of his priorities is flood defence so we will offer him all the support we are able and work with him and other local Parish Councils to share best practice and resources.

Please do your bit to keep us all safe and there is loads of Environment Agency information and advice online, well worth a look.

# Could you be a Community Flood Warden for the Cotswolds?



Residents at risk of flooding in the Cotswolds could soon be getting a helping hand from community flood wardens thanks to a new initiative from Cotswold District Council.

Cotswold District Council is launching a new flood warden scheme with the help of Gloucestershire Rural Community Council (GRCC). The scheme will involve recruiting and training volunteer flood wardens from across the district and provide information and advice to householders on flood precautions.

The Flood Warden programme will look to work closely with town and parish councils to recruit and train volunteers across the district, with those areas most prone to flooding targeted first for the scheme.

Flood Wardens act as the eyes and ears of the community. Whether they are out walking their dog, riding a horse or just walking to the shop they can keep an eye out for blocked drains and culverts, tree branches in rivers, and anything else that may cause a flood risk and act as a communication channel between the community and authorities. The Council will provide volunteer wardens with the tools and training necessary to get the job done.

In addition to being community flood watchers, flood wardens are trained to raise awareness of **flooding with residents and promote 'self-help'**. The knowledge of local flood wardens is then used to support the preparation and review of Community Flood/Emergency Plans.

Cotswold District Council is working alongside GRCC to roll the initiative out in advance of the next winter season. Further details will be published on our website over the next few weeks.

**Earlier in the year, over 100 residents attended the 'flooding forum' run by Cotswold District Council** for residents affected by the flooding over the winter with the aim of surfacing issues with the responsible agencies and solving long-standing issues with flooding across the Cotswolds. The Council also wrote to Thames Water in an open letter to try and resolve some of the problems with sewage flooding in Cirencester.



# Unmanned Aircraft Flight Restrictions around RAF Fairford

RAF Fairford is experiencing an increasing number of Unmanned Aircraft Systems (UAS), or drones, flying within its Flight Restriction Zone.

UAS operators flying drones near any military airfield must ensure they are aware of the UK policy for their safe operation. When you fly a drone in the UK it is your legal responsibility to be aware of the rules that are in place to keep everyone safe. Due to their small size and maneuverability they are hard to spot and identify by pilots of larger, faster moving aircraft. This means they may not see it until they have already hit it, which could cause major damage and potentially loss of life. The Operations and Safety teams at RAF Fairford are committed to providing a safe operating environment and will provide the latest information as it becomes available.


The Drone Code forms part of the Civil Aviation Authority's guidance to drone operators which can be found on the website <https://dronesafe.uk/drone-code/>



The Drone Code refers to an airfield's Flight Restriction Zone and it is illegal to fly anywhere in this area without permission from the air traffic control unit at the aerodrome.

The permitted 'operating height' is limited to a maximum distance of 400 feet (120 metres) from the closest point of the **earth's surface**.

The Flight Restriction Zone also includes a 2.5 nautical **mile radius "cylinder"** around the airfield, extending 2,000 ft above ground level; a rectangle extending 5km from the threshold of each runway away from the airfield and 500m either side, also to a height of 2,000 ft above ground level; and can be extended across unprotected areas by 1km beyond the airfield boundary.



Further information is available on the drone safe website.

Operations within the Flight Restriction Zone may be permitted, but permission **MUST** be sought from the appropriate authority, which in this case is RAF Fairford Airfield Operations.

The base has a Drone Request Procedure and all enquiries should, in the first instance, be sent to the Community Relations Adviser, Jenny Collyer, at [jennifer.collyer.2.gb@us.af.mil](mailto:jennifer.collyer.2.gb@us.af.mil) / 01285 714965, or the Airfield Operations Chief at [420abs.osa@us.af.mil](mailto:420abs.osa@us.af.mil) / 01285 714820. A minimum of 5 working days is required to process a drone request

## Walk 7: Thames Path and Watery Lane



Distance **5.04mi**      Moving Time **1:39:37**      Pace **19.46/mi**

This month's walk starts from our house. It could have started from The George but just as I am putting my running shoes on an email came in from my literary agent aka the Kempford PC Clerk wondering whether there would be a WOTM for the September Parish News. The George is 108 paces from our back door (never measured on the way back!) so you can add that to the Strave 5.04 miles if you like.

This walk does involve too much road, but you could start from where we started the Thames Path East and the Pentylands Lane walks i.e the first right hand bend after the Thames bridge. To reduce the road content I walked up Ham Lane and then took the 1st right at the 5 way junction. This will take you to the road to Hannington but first you walk alongside a small lake on the right (Pic 1) and cross the route of the old canal. Perhaps one day we will hear the sound of narrowboats chugging along there instead of the screech of the spy plane above me. I can't believe the steps some people take to learn the Walk of the Month route before it is published in the PN. When you emerge at the road turn left and head to Hannington Wick. Pic 2 shows the Thames from the bridge, which many of you will know.



Just after the bridge a “Wide Loads” vehicle appeared followed a few minutes later by a humongous combine harvester. I was by now on the next bridge and the driver motioned for me to cross the road hoping (I assume) that he had less chance of squashing me against the wall on that side. Just after this you turn right onto the Thames Path. Walk through 4-5 fields and look across the river at Kempford church (Pic 3). You will then come to a cottage (Pic 4) and the start of tarmac that would ultimately take you to Castle Eaton. However we need to turn left here down a bridleway and after perhaps 300m follow it around to the left. After a similar distance you will come to a bridge that leads into an arable field - see Pic 5. A heron heard me and flew out of the ditch. Is it just me or do you never see “Mr and Mrs Heron”? The barley didn’t look great which backs up what I had heard on the farming news on Saturday morning. Quite a few years ago my neighbour Pete and I had set a “hash” run ( [www.cvh3.co.uk](http://www.cvh3.co.uk) ) from either the George or the Red Lion, CE. That year the crop had not been sprayed where the path is and the healthy wheat “scythed” our thighs as we tested the route on the Sunday afternoon - knowing that we would have to repeat the pain on the Monday evening with the “athletes”.



At the end of the field carry straight on into Watery Lane (pic 6). This is now a good path and was not too wet even after all the rain on Saturday. I think it was probably on the same hash as above when Watery Lane lived up to its name - shin high water for most of the path. This will bring you out onto the Hannington Lane on the bend by Yew Tree farm. I’m guessing that a lot of you have seen the Watery Lane sign on that bend and wondered where it went.

Sadly there is no easy way back to Kempford to keep the walk around the 5 mile mark so I just walked up the road. At least you get the smoothest bit of tarmac in Gloucestershire (for about 50m!) where the badgers dug up the road.
